Fire Department

Councillor H. Shears reported that 15 members attended the last meeting. There were two fire calls in February. Councillor Shears thanked the fire fighters for their work with the ice rink. The fire fighters will be applying for a moose license again this year. Basic Emergency Management training is being offered. Town Manager, Len Hann has attended. Councillors and staff are encouraged to attend the training as well.

Public Works/Planning & Development

Councillor Boyd reported that with spring coming the roads will be messy and there will be some ice buildup. Potholes will be monitored and repaired in spring as well.

Recreation

Councillor T. Alexander reported that the new ice rink is being well used and well looked after.

Finance

Councillor Howlett reported that it has been a quiet month financially but will be getting busy with projects for the fall and summer.

Communication/Beautification/Policy

Councillor Dawson reported on the recent Southwest Coast Joint Council Meeting in Port aux Basque:

- 1. Waste Management Presentation The Waste Management is now called Western Regional Services Board. Their function is to look at the potential sharing of services which may be migrating towards regional government.
- 2. Fixed Link Will diminish traffic between Corner Brook and Port aux Basque. Financial responsibility will be determined at a later date.
- 3. Representative from Stephenville Crossing advanced the proposal for lights to be placed on Indian Head.
- 4. Port au Port West Representative is looking for possible childcare subsidies for single parents to attend MNL meetings and Joint Council Meetings.
- 5. Councillor Tobin of Stephenville presented a letter from the chair of the Stephenville Airport Committee detailing the serious straights that the airport is facing. It was requested that all of the councils in the southwest corner write their MP's and MHA's to voice support for the airport.
- 6. Councillor Dawson put forward the need for Municipal training for Capital Funding applications.

- 7. The annual Symposium is being held April 30 May 2, 2020 in Gander.
- 8. The Western Regional meeting of MNL will be held June 26-27, 2020.

Councillor Dawson offered to provide council with more detailed notes of the meeting.

Councillor T. Alexander left the meeting.

Mayor's Report

Mayor Brake-Patten reported that the whole world is in crisis over the corona virus. Precautions will be taken. Staff will be available to help with any issues that might arise. Mayor Brake-Patten met with chair of Recreation Committee and Seniors Committee to discuss the availability of the Community Centre.
