

Contract between Containerized Sanitation Ltd

&

Town of Kippen's

To provide weekly curbside pick-up of household waste and recycling collection and disposal to the Town of Kippen's. All pricing and conditions listed herein will remain in effect throughout the life of the contract.

The contractor must provide an up to date COR certification, and a letter of good standing with WHSCC.

Rules as follows:

- Waste/Recycling is to be placed at the curbside by 8:00am on the assigned day.
- Waste must be placed in a clear bag and Recycling must be placed in a transparent blue bag, as required by Western Regional Waste Management.
- 4 clear waste bag limit per household.
- Unlimited recycling bags
- Bag weight limit of 40 Pounds/18 Kilograms.
- 2 small privacy bags permitted per clear waste bag.
- Sharpe Objects** (Hypodermic Needles and Broken Glass) must be placed inside a puncture resistant container with cover before being put in the waste.
- Recommended that garbage bags be covered with a blanket/net or be placed inside a mobile waste container with attached cover to deter animals.
- Permanent garbage boxes are **NOT** permitted
- Bulk waste **NOT** permitted at curbside except during community cleanup
- Contractor is **NOT** responsible for clean up of debris due to torn/ripped waste bags

Additions:

-Contractor will provide weekly pickup from a garbage box at the following locations:

Kippen's Community Centre (Gaudon's Lane)

Seniors Living complex (18 Kippen's Rd)

-Contractor will provide two community cleanups which will be included in the contract price. One in the spring and one in the fall of the year, specific dates will be set/agreed upon accordingly.

-Collection days falling on statutory holidays will be re-scheduled to the next business day

Contract Duration:

-Contract life will be from December 6th, 2023-December 31st, 2024.

-Contract may be extended up to a period of an additional 2 years at the Town of Kippen's discretion, contract price before HST will increase by 2% annually for each year the contract is extended.

Contract Price Excluding HST \$89,955.77

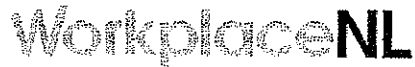
