## **Committee Reports**

# **Fire Department**

Councillor H. Shears reported that 15 member of the fire department attending their last meeting. An open house was held on October 6<sup>th</sup>. The annual volunteers' dinner will be held on December 7<sup>th</sup> this year.

# **Public Works/Planning & Development**

Deputy Mayor Benoit reported that the McCarthy's Lane project is progressing well. There have been some problems such as the curbs being too high in a couple of places. A solution was found and the problem rectified. Paving will commence the beginning of next week. The residents seem pleased with progress and previous water issues have been resolved. An additional water issue caused by a bog

being filled in will also be resolved. A problem near the beach where some of the rock was used has also been fixed.

# **Public Works/Planning & Development**

Councillor Boyd agreed with Deputy Mayor Benoit's account of the current planning and development and public works issues.

# Recreation

Councillor Alexander reported that the Volunteers Christmas party is on December 7<sup>th</sup> which is also the same date as the Kinsmen Christmas Parade. As a result, Kippens will not be putting a float in the parade this year.

#### Finance

Councillor Howlett reported that departments need to submit the budget requests soon for consideration in the 2020 budget. Groups that wish to request larger donations would need to meet with council and present financials and a business plan.

#### Beautification

Councillor Dawson reported that the town manager was able to purchase some deciduous trees at a cost savings. They are being planted throughout the town. There are still communication issues with the electronic sign.

## Mayor's Report

Mayor Brake-Patten reported that any decision that council makes will be done so with a majority of council. Council makes their decisions based on research and insight. Council relies heavily on the staff to provide information to allow them to make informed decisions. When council makes a decision it is based on research, doing their own homework and doing what is best for the Town of Kippens. Council is happy to serve the public and will continue to do so. Work will begin on the budget next. Mayor Brake-Patten reported that Andrew Smith has been hired as town planner for Kippens and council will be meeting with him November 6<sup>th</sup>.
