### **Committee Reports**

## **Fire Department**

Councillor H. Shears reported that 19 fire fighters attended the last meeting and 15 fire fighters attended training on Firemen Level 1 certification. The boot drive will be held on December 21<sup>st</sup> on Kippens Road. Proceeds will be going to two different charities.

#### **Public Works/Planning & Development**

Councillor Boyd reported that discussions have been held with the garbage contractor regarding plastic bins and hopefully there will be a new policy within a couple of months.

Ditching is required on McCarthy's Lane that was not included in the capital works contract. Contractors supplied the drain at the edge of the road and approximately 100 meters of ditching is required to resolve the water problem on private lawns. The new pavement will not be disturbed. It will be cheaper and quicker to resolve this issue now rather than having gone through the capital works process. More information and bids/quotes will be brought to council for a vote. The culvert has been installed on Seaside Drive. A heavy rainfall the following day caused silt to shift and block part of it. An excavator may be required to clear it out.

Mayor is disappointed there are still water problems on McCarthy's Lane and states more time was spent on the fire road.

#### Recreation

Councillor Alexander reported that the Kippens Winter Carnival is February 7-9, 2020. The Seniors Appreciation Supper is November 24<sup>th</sup> and the Volunteer Christmas Dinner is December 7<sup>th</sup>.

## **Finance**

Councillor Howlett reported that staff is working on the 2020 budget process and councillors input would be encouraged. The Town is holding its own financially due to years of good management. However, there is no development in Kippens and the population in Newfoundland is decreasing. Councillor Howlett, Mayor Brake-Patten and Councillor Alexander will meet next week to review the first draft of the 2020 budget.

#### Beautification

Councillor Dawson reported that there has been a meeting with the garbage contractor. Councillor Dawson was able to speak with Josh Carey at the MNL Convention regarding garbage issues. In all likelihood, it seems that Western Newfoundland will face increasing tipping fees unless government is willing to devise a way to even things out. Josh Carey will be at the Southwest Coast Joint Council meeting in St. Georges on November 30<sup>th</sup> and all councillors are encouraged to attend.

### Mayor's Report

Mayor Brake-Patten reported that council will work on the committee structure as a whole. The Senior's Dinner will be this Sunday, November 24<sup>th</sup> and the Volunteers Appreciation Dinner and Dance will be December 7<sup>th</sup>. There has been one encouraging meeting with the new town planner Andrew Smith.
