New Business

Permits

Council decided that more time was required to make a decision and respond to Stephenville regarding the development permit application within the Kippens wellhead protected area. Council needs to review all of the information coming in on the issue. Mayor Brake-Patten stated that she would like to see one voice for council and not all councillors contacting government officials. Either the town manager or one individual can keep all of council in the loop. Deputy Mayor Benoit stated that it is the responsibility of the town manager to get information and distribute it to all of council. All correspondence should go through the town manager.

Mayor Brake-Patten would like to see the permit for a house at 34 Orchard Lane voted on again as she feels council had very little information available when voting on the approval in principle in the fall of 2018. Upon review of the Millbrook Development file, Mayor has grave concerns about that area and lack of planning and development meeting minutes. Councillor Dawson observed that in the past only Recreation and Fire Department meeting minutes were brought to council. However, on a go forward basis the chair of each committee will be expected to present a set of committee meeting minutes to council. Deputy Mayor Benoit informed council that the permit was brought to a Planning & Development Committee meeting and met all regulations, including Department of Health for approval. The permit was then passed by council. Deputy Mayor explained that the Town Manager has authority to issue permit if in compliance. Mayor would like to see all of council review the Millbrook Development file as she feels things have changed in the subdivision specifically environmental issues. Deputy Mayor stated that plans for this property are well inside the buffer zone and they have received Service NL approval for a septic system. Mayor Brake-Patten stated for the record that she is opposed to the permit issued for a house at 34 Orchard Lane after reading the Millbrook Development file. Mayor also wanted recorded that Councillor Howlett stated that if the requirements for the permit are not met as stated by the Town Manager than the responsibility lies with the Town Manager.
