Committee Reports

Finance

Councillor Howlett reported the financial items are low for the last two weeks. Town taxes are still being collected at a fairly good percentage. Alternative payment options have been arranged such as by credit card over the phone and email transfers without having to come into the building. The interest on 2020 taxes has been extended to June 30, 2020 to be revisited at that time.

Public Works/Planning & Development

Councillor S. Boyd advised council that clean up week seems to be going well with the bins. Once the weather improves residents will be out cleaning up.

Public Works/Planning & Development

Deputy Mayor L. Benoit reported that he is pleased to see that an approval in principle was issued for a senior development in lower Kippens. Preparations are being made to have everything in order before the Edwards Lane Project goes to tender. Deputy Mayor Benoit thanked the administrators for their hard work in recognition of Town Clerk Week.

Recreation

Councillor T. Alexander reported that recreation committee is waiting for guidelines from Department of Health in order to plan for the summer recreation activities.

Recreation/Fire Department

Councillor H. Shears reported that Canada Day celebrations have been cancelled as social distancing cannot be guaranteed. Perhaps fireworks will be displayed on the town sign during the day, thanking residents and advising everyone to stay home and stay safe. The committee is hoping to save some of the summer recreation program following the guidelines of level 3. The chair of recreation is in contact with a government representative and a nurse for advice. Options for length of program and capacity are being discussed.

Communication/Beautification/Policy

Councillor Dawson reported that he and others participated in the workplace webinar. Work will commence again on the Respectful Workplace Policy which will be shared with the HR committee for feedback and then presented to council next month for adoption. The Electronic Sign Policy will be amended to recognize milestones in the lives of the residents such as birthdays and anniversaries. Another addition would be to encourage and support

local businesses in town. The Hillside Interfaith Cemetery cleanup is being done, the draft budget has been completed and people are arranging for cutting and trimming.

Mayor's Report

Mayor Brake-Patten reported the Newfoundland has gone seven days with no new cases of Covid-19 and hopes this is a sign that the curve is flattening. Mayor wanted council to know that she emailed town clerk on May 4th with a happy town clerk week message but town clerk did not respond. Town clerk acknowledged receipt.
