Deputy Mayor Benoit expressed his concerns regarding the increase in legal fees since 2013. Accusations were made by a resident regarding some councillors being in conflict of interest. This cost the Town \$7,200.00 and were false. In order to avoid some legal costs council could have made an internal decision but didn't. Deputy Mayor stated that council needs to be more respectful of employees so that it does not cost more money in legal fees. According to OHS council must provide employees with a safe workplace. This has cost the town \$16,000.00. A more respectful workplace is need and councillors need to be conscious of what they say and do. This will save the town some money. Mayor Brake-Patten reminded Deputy Mayor Benoit that it was at his request that the town got a lawyer to review the conflict of interest allegations. Deputy Mayor agreed because the issues were taking too long to resolve. Mayor acknowledged that the Town and four councillors are being sued by a contractor and legal costs may incur. Deputy Mayor clarified that those pending costs are through the insurance. Councillor Howlett acknowledged that the general operations of the town is becoming more legally complex forcing the town to defer to legal advice.

Councillor Shears expressed her opinion on the additional office staff wages for a casual person. Clarification offered on the casual position.

<u>Motion #220/20:</u> Motion by Deputy Mayor Benoit, seconded by Councillor Dawson, be it hereby resolved to accept the resignation of the Town Manager, Lenny Hann.

Deputy Mayor Benoit read a prepared statement regarding the resignation of town managers. He is receiving calls from residents asking why the Town is going through so many town managers. What is the Town doing wrong? Three of the previous managers felt they were being micromanaged and disrespected by certain members of council. All former managers were professional people. Emails have been sent that are disrespectful about staff and to staff. Deputy Mayor read an email this summer sent to a former councillor telling him that the office will be cleanup before the end of the term. Staff has been on the edge of their seats wondering if they will lose their jobs and how restructuring might affect them. Attempts have been made to try and turn staff members against each other. Deputy Mayor gave examples of inappropriate behaviour towards staff such as the manager receiving a phone call from a resident at a councillors house between 9:30 and 10:00 on a Friday night and accusations of being in cahoots with contractors on Mccarthy's Lane. The Town Manager has been accused of lying in front of four residents and has been micromanaged. He was demanded to give permits when not in compliance, received numerous phone calls and emails after hours that were not

emergencies. He was accused of working with certain coucnillors and forced to second guess decisions he had made. How can staff work under such toxic conditions? It is required by law to have a safe and respectful workplace and we have to abide by it. The abuse must stop. Lenny Hann has been patient, respectful and worked above and beyond. Mr. Hann worked with Roads & Maintenance Committee to see Island Pond Drive completed, McCarthy's Lane storm sewer and pavement, Edwards Lane and a large section of Oceanview Drive. Last years Mr. Hann worked with staff and contractors all weekend to ensure the residents did not run out of drinking water. The comments on social media are disheartening. Mr. Hann also volunteered with Canada Day activities, Kippens Recreation, Fire Department, Winter Carnival, Christmas float and many others. This is truly a sad day to see another manager quit the job for all the wrong reasons. There is a common denominator on council and the only time to make changes will be in the fall of 2021. Deputy Mayor Benoit feels ashamed there was not more he could do to help the town manager.

Councillor Dawson expressed his concerns regarding the turnover in town managers and accepts the resignation of Mr. Hann with considerable regret. Councillor Boyd concurred with the statements made and wished Mr. Hann the best of luck. Councillor Alexander also wished Mr. Hann the best of luck.

Deputy Mayor Benoit thanked the HR committee for their hard work on the Respectful Workplace Harassment Prevention Policy. The policy will be sent to Occupational Health and Safety for final review. The policy will be distributed to all councillors for review and then brought forward for adoption.

Work is being completed on the dog park. There is ongoing work on the outfall on McCarthy's Lane involving the engineer and contract. Deputy Mayor wished council and staff a Merry Christmas and acknowledge the hard work of the finance committee and staff on the budget.

The HR committee will be looking at the vacant town manager position very soon.

### **Finance**

Councillor Howlett reported that the budget focuses on the core responsibilities of the town such as clean and safe drinking water, plowing roads, collecting garbage and so on. It is a delicate balance deciding where to put the

money. The town is in a good financial position and will continue to provide the services the residents expect and deserve while growing our recreation. Councillor Howlett states it is fun and an honor to work with the council, staff and volunteers in the Town. He acknowledges the work of the committees and the negative feedback that is received at times. If residents feel things are not what they want, they should run in the next municipal election. Councillor Howlett recommended the town have a look at the vehicle fleet and consider vehicle replacement and finances.

Mayor Brake-Patten reported that this is the last budget for the term. She loved serving as Mayor. It has not been easy and 2020 has not been easy with the COVID pandemic. It has been difficult with getting threatening letters from developers' lawyers. However, council has managed to stay together, move forward and take the high road. Mayor Brake-Patten thanked the volunteers, councillors and staff. Thanks to Lenny Hann for all he did while serving the Town, best of luck in his future endeavors and best wishes to him and his family. Merry Christmas and Happy New Year to all those in the community. Hopefully 2021 will be a better year.
