Deputy Mayor thanked Councillor Boyd for all the things he does for the town especially with the loader and coming up with some great ideas for the sand truck. The process for receiving the salt shed has been postponed due to the election.

Councillor Howlett reported that some costly repairs to the equipment were avoided. He acknowledged the extra work that has fallen on the clerk the last couple of months due to the vacancy of the Town Manager position. Councillor Howlett would like to work on finishing some projects and get some things done as the term for this council winds down.

Councillor Boyd reported thanked Deputy Mayor Benoit for his comments and advised that he is available to help out.

Mayor's Report

Mayor Brake-Patten reported that the dog park will be finished when the weather clears up. Work will commence on the green space on Orchard Lane in the spring.
