The Acting Deputy Mayor stated that...

"To be qualified to be Nominated under the Municipal Elections Act Chapter M-20.2 section 15:

15. (1) A person is qualified to be nominated as a candidate for councilor who

(a) is eligible to vote in an election held under this Act in the municipality in which he or she is nominated to serve as a councilor;

(b) is not in arrears of taxes or other charges payable to the municipality; and

(c) is ordinarily a resident for a period of 30 days before the commencement of the nomination period either in the municipality or in an area that on election day is part of a municipality.

Residents please take note – If you are unable to vote in person on election day you have to obtain a Vote By-Proxy form from our Town Office and return it to our Returning Officer not later than 4:00 pm on the day immediately preceding the election: August 16, 2022. Online Proxy forms are not accessible! If you require any further information, please do not hesitate to contact the Town Office".

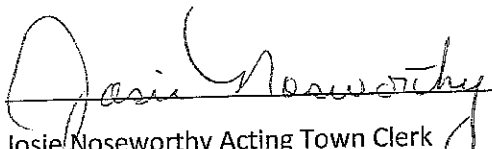

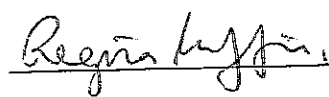
